FACTS Enrollment Management Company

St. Malachy School has contracted with FACTS Management Company to manage our tuition payments. You will be receiving a Tuition Account Billing Statement from FACTS Management Company in June. It will list your total tuition & fees balance due to the school for the upcoming school year along with instructions on how to enroll in a payment plan online. Enrollment in FACTS must be completed by June 1, 2021. Tuition paid in full by July 1, 2021 can be paid to the school directly. All others will go through FACTS. There is a \$10.00 fee to enroll through FACTS for 2 payments, more than 2 payments the fee will be \$43.00. This fee will be due at the time of enrollment. A late fee of \$15.00 will be assessed if a monthly payment is received 10 days past the date due.
