In an effort to make Catholic education more affordable for both our parishioner and non-parishioner families, St. Malachy prioritizes keeping tuition as low as possible. To do this, an annual subsidy is provided to the school ministry for the benefit of the families attending. This subsidy is funded through Sunday collections.



Family Service Deposit

The service requirement is based on the example of Jesus, who stated that He came among us "not to be served but to service" (Matthew 20:26). Volunteering and serving on campus is a great way to lead by example, collaborate with other families, and to use your time, talent, and treasure to support, enrich and strengthen St. Malachy. Each family is required to complete 20 hours of service to our parish/school. The \$200 deposit will be refunded or reapplied once the service hours are completed. This deposit needs to be paid in full before August 1, 2022.

FACTS Enrollment Management Company

St. Malachy School has contracted with FACTS Management Company to manage our tuition payments. You will be receiving a Tuition Account Billing Statement from FACTS Management Company in June. It will list your total tuition & fees balance due to the school for the upcoming school year along with instructions on how to enroll in a payment plan online. Enrollment in FACTS must be completed by June 1, 2022. Tuition paid in full by July 1, 2022 can be paid to the school directly. All others will go through FACTS. There is a \$10.00 fee to enroll through FACTS for 2 payments, more than 2 payments the fee will be \$43.00. This fee will be due at the time of enrollment.
